Applicant acknowledges that the principal place of business of Geary Pacific Corporation/Geary Pacific Supply and the location where performance of the credit agreement and payment is to be performed is in Orange County, California. The applicant agrees that in the event of suit to enforce payment, venue and jurisdiction will take place in Orange County, CA, or in the jurisdiction where shipment originates, or in the jurisdiction where applicant resides at the option of Geary Pacific Corporation/Geary Pacific Supply.

If credit is extended, the applicant agrees and understands that full payment is due within 30 days from date of invoice, regardless of non-payment from your customer. The applicant agrees to pay a monthly late charge of 1.5% (18% per annum) on any past due balance. The applicant further agrees to pay all of Geary's collection costs and attorney's fees should an action be brought to collect this account. All purchases subsequently made shall be subject to these terms and conditions.

All goods are delivered F.O.B. shipping point. Prices are subject to change without notice, unless a written quotation with an expiration date is provided by Geary Pacific Corporation/Geary Pacific Supply

Goods may be returned with permission. All returned merchandise is subject to a restocking fee. Special orders are non-cancellable and not returnable.

Shortage and/or damage claims will not be considered unless claim is made on the shipping document at the time of receipt of product.

Warranty, when applicable, is limited solely to such warranty as the manufacturer furnishes. Geary Pacific sells items "as is" and gives no warranty of its own. Geary Pacific will assist you in filing your claim under the manufacturers warranty provisions.

Any change in the business structure, ownership, creditworthiness, or any other fact which might relate to Geary Pacific's decision to continue extending credit will be reported to Geary Pacific's credit department in writing, sent by certified mail, return receipt or by such other means as will generate a written receipt by the credit department. Any other delivery of such information is presumed to be ineffective to give notice.

Applicant agrees that Geary Pacific may elect, at its option, to serve preliminary notices related to all projects for which materials are purchased and may, at its option, enforce any and all Mechanics Lien, Stop Notice, and/or Bond rights and related remedies. The failure of Geary Pacific to enforce such 3<sup>rd</sup> party rights shall not diminish, dilute, or be a defense to any claims against the applicant.
